- **3. Roll Call** Chairman Billy King (all present)
- **4.** Approval of the June 20, 2017, Courthouse and Property Committee minutes Motion to approve, (Yockey, Heflin) unanimous.
- **5. Zoning Reports** Chris White was not present and reports were sent out prior to the meeting. They were accidently left out of the packets so it was deferred to next month.
