## **Request for Proposal**

### **Concrete Pad for Ag Center Building #2 Bid No. 21-15**

The Bedford County Department of Finance is requesting proposals for a Concrete Pad for Ag Center Building #2. Sealed bids will be received until **2:00 p.m., Wednesday, November 4, 2020**, in the office of the Bedford County Department of Finance and will be opened publicly at that time. The Department of Finance reserves the right to reject any and all bids and waive any irregularities for the purpose of ensuring that the award given is in the best interest of Bedford County. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.

## GENERAL BID TERMS AND CONDITIONS

Proposals from all responsible bidders will be considered. To qualify as a responsible bidder, the proposal submitted must:

1. **Meet or exceed the minimum requirements specified.**
2. **Furnish all documents requested by the representative of the Bedford County Department of Finance prior to and following the bid opening.**
3. **Submit their bid, complete, prior to the bid opening date and time.**
4. **Have bid name and bid number placed on the outside lower left corner of the sealed envelope containing the bid form. (Facsimile bids will not be considered.)**

### Award

A purchase order from the Bedford County Department of Finance will be issued to the successful bidder acknowledging the award. A copy of these terms and conditions, specifications and the vendor's proposal form will become a part of the purchase order.

Lowest and/or best bid will be awarded.

### Other Considerations

Bedford County Department of Finance reserves the right to purchase only those bid items and quantities that conform to overall budgetary, functional, and performance constraints.

The terms of this bid will be extended to other local government agencies, other municipalities, and Boards of Education. Bedford County is responsible only for purchases made and received by Bedford County.

Bedford County of Tennessee ensures compliance with Title VI of the Civil Rights Act of 1964; 49 CFR, part 26; related statues and regulations to the end that no person shall be excluded from participation in or be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance from the U.S. Department of Transportation on the grounds of race, color, sex or national origin.

### INSTRUCTIONS TO BIDDERS

Proposals are to be made on the Proposal Form provided. **Bids must be delivered in hand or by a mail service in a sealed envelope marked on the outside lower left corner, Bid No. 21-15 Concrete Pad for Ag Center.** Bids will be received and opened at **2:00 p.m., Wednesday, November 4, 2020.** **Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.**

Proposals are to be made complete in every detail as required and called for by said Proposal Form. Proposals that are incomplete, conditional, contain irregularities of any kind, or which are not in accord with the Instructions to Bidders and Proposal Form furnished by the Department of Finance may be rejected as informal.

The submission of a proposal will signify that the Bidder has thoroughly familiarized himself with all conditions and that he fully understands what will be expected of the successful bidder.

The Department of Finance reserves the right to accept or reject in whole or in part any or all proposals submitted, without liability whatsoever, and waive informalities therein, if deemed by the Department of Finance in their best interest to do so.

## SPECIFICATIONS

This project will be pouring a concrete floor inside Building #2 at the Ag Center located at 2119 Midland Road, Shelbyville, TN. Perspective bidders are encouraged to arrange to view the project area before bid opening.

1. Install 5" of 4,000 PSI concrete
2. Pad size – 100' by 200'
3. Install 6" wire mesh under concrete pour
4. Contractor to furnish concrete and labor
5. Contractor to finish pad grade prep for pour (Grade will be within 1" of final grade) (Stone provided by owner if needed)
6. Concrete final surface will need to be broom finish
7. Contractor will install expansion joints every 15' in a cross pattern (If contractor suggest another expansion plan please add to bid)
8. All materials needed furnished by owner for prep work up to concrete pour (stone, wire mesh, drainage infrastructure)
9. Drainage grate tops to be installed by contractor for finished grade of concrete
10. Please list warranty information for concrete pour (if any)
11. Contractor must have insurance information included in bid packet
12. Contractor must have workers' comp and liability insurance provided for \$1,000,000
13. Contractor will be required to post a bond or letter of credit for bid amount to Bedford County Finance Department. This will be released after approval of contracted work.
14. Project must be completed and approved by County by December 15, 2020
