## **ABSENTEE VOTING BY MAIL**

IN ORDER TO VOTE ABSENTEE BY MAIL, A VOTER MUST MEET CERTAIN LEGAL QUALIFICATIONS. A VOTER DESIRING TO VOTE ABSENTEE BY MAIL, SHALL IN WRITING OVER HIS SIGNATURE EITHER IN PERSON AT THE ELECTION COMMISSION OFFICE OR BY MAIL, REQUEST AN APPLICATION FOR AN ABSENTEE BALLOT. SUCH REQUEST FOR AN APPLICATION MAY BE RECEIVED NO EARLIER THAN THE 90<sup>TH</sup> DAY PRIOR TO THE ELECTION, AND MUST BE RECEIVED NO LATER THAN JULY 30<sup>TH</sup>, 2020. THE REQUEST CAN SERVE AS AN APPLICATION FOR BALLOT IF IT CONTAINS THE FOLLOWING: NAME, ADDRESS OF RESIDENCE, SOCIAL SECURITY NUMBER, DATE OF BIRTH, ADDRESS TO MAIL THE BALLOT TO, THE ELECTION/S THE VOTER WISHES TO VOTE IN INCLUDING PRIMARY IF APPLICABLE, THE REASON THE VOTER WISHES TO VOTE ABSENTEE, AND THE VOTER'S SIGNATURE.

### **REASONS TO VOTE ABSENTEE (BY MAIL)**

- 1) VOTER OUTSIDE OF COUNTY DURING EARLY VOTE AND ELECTION DAY
- 2) STUDENT OUTSIDE OF COUNTY DURING EARLY VOTE AND ELECTION DAY
- 3) SERVING ON JURY DURING EARLY VOTE AND ELECTION DAY
- 4) ANYONE OVER 60
- 5) INACCESSIBLE VOTING LOCATION
- 6) HOSPITALIZED, ILL OR PHYSICALLY DISABLED
- 7) CARTAKER OF HOSPITALIZED, ILL OR PHYSICALLY DISABLED PERSON
- 8) CANDIDATE
- 9) ELECTION OFFICIAL
- 10) OBSERVANCE OF RELIGIOUS HOLIDAY
- 11) PERSONS WITH VALID COMMERCIAL DRIVERS LICENSE THAT WILL BE OUT OF THE COUNTY OR STATE DURING EARLY VOTE AND ELECTION DAY
